  - b. We don't want a whole new board each time, so when we update the bylaws, there will be discussion about staggering position terms.

    - iii. Haley Bogdan and Kayci Muhvich- Secretary
    - iv. Scott Kellerman- Treasurer
  - c. Have to be an active member to vote.
  - d. Ballots will be made out a week in advance and will be at the bar for active members to vote.
  - e. Bartenders will have to check memberships.
- 30. Gambling Committee:
  - a. Jenn Cole, Sue Meskill, and Haley Bogdan are interested in helping.
- 31. Bar Operation/Budget Committee: oversee what is going on in the bar.
  - a. Kurt, Dede, and Scott are interested in helping.
  - b. Dave Gruba Motioned and Kurt M Seconded- motion carries.
- 32. DNR Grant:

33. Mike B court letter:

- b. Jenn C makes a motion that the club request a letter from the attorney stating that Mike B can come to the membership meetings before the court order expires in April. Dusty seconded- All in favor- motion carries.

34. The attorney and the AGO need copies of what is in the "red binder" back to July.

- a. Brianna is ONLY to give Mike B what is in the "red binder" completed or not. Just whatever we were shown at the membership meetings is what he will be given.
- b. Once he receives what he needs, Kurt will go and get it notarized that he received his things.

35. Square Loan is still in process: \$19,000 to go to Highland from Square.

36. Dusty is going to get a hold of Tom Nemanich this week to get an actual amount for what we owe.

37. Balance sheet in the future.

38. Dusty and Kurt had a zoom meeting with the attorney:

- a. The Club owes roughly \$37,000 (rounded up).
- b. They will take payments
- c. Just sent another \$5,000 check.
- d. Lack of cooperation of the gambling side has resulted in our cost being over \$20,000.
- e. We need to work on our Bylaws.
- f. GCB got extended to Dec. 31st
- g. Audit- The audit is finished but not finished with the original software. The software issues were never fixed, but Brianna is working on that.
- h. GCB will be a little lenient with some of the information that we may have never had.
- i. The P.I will get involved when the audit from 2022 is finished.
- j. Anything over \$750,000 needs to be audited by a CPA for gambling.
- k. Dusty makes a motion to pay Walker Drew and Hanuy the remaining balance from 2022. - all in favor-motion carries.
